3. Council vacancies

The parish council elections held on 7th May 2015 was uncontested and resulted in Stella Beavis, Paul Goodman, Michael Ryan and Ghassan Sheraidah being elected. There are sufficient candidates (Councillors) to provide a quorum for meetings, however there are still three vacancies. We are required to co-opt (qualified) people to fill the remaining vacancies within a period of 35 working days from 7 May2015. Failure to exercise this power may result on the District Council exercising its power to order a fresh election to constitute the Council. PG proposed and GS seconded that as both Richard Northcote and Stuart Richards had previously been members of the council and that they were willing to stand again they be co-opted onto the council, agreed unanimously.

4. Chairman's report

The year has been marked by a number of significant events including:

The recruitment of a new Parish Clerk, Lynda Baker, following the retirement of the previous Clerk, Chris Hewson, and a period when the position was covered the Hunsdon Parish Clerk, Joy Robinette.

Input to East Hertfordshire District Council's Draft Development Plan representing parishioner's concerns regarding potential development to the North and East of Ware within the Wareside Parish boundary.

Comments to East Herts District Council regarding Ware Town's draft Neighbourhood Plan and the impact on Wareside. As a result of these comments Ware Town Council are expected to have to amend and resubmit their application.

The lease for the land adjacent to Kingham Road for recreational and allotment use was finalized in September.

Open meeting with parishioners to assist in the setting up of the allotment association and agree terms between Wareside Parish Council and the Wareside Allotment Association was held.
